
1 - Read through notes from 28/Jan/2022 Meeting. The key actions are listed below with an update:

Comment	Action	Result
1 - Precept 2022/23	Agreed a 2% increase to precept – SCC noted would generate £23,056 (£0.52) increase per household	The PC members agreed unanimously to increase the precept by 2%. The PC felt that there was a need to elevate the precept due to inflations and running cost increases, however, could afford to limit the increase this year based on pandemic impact on parishioners. DH Filled in the form and signed off
2 - Big Idea	Discussed the Village Hall and reflected upon the Zion Chapel process and how the PC now intend to support BHVH. Discussed previous suggestions and how they feel 2 years on. Agreed that the VH should have facilities fit for the parish/village and aim to include the younger and older members of the parish.	PC undertook consultation and decided not to proceed. The Zion Chapel has since been sold and an application for a day care nursery has recently been unsuccessful.
3 - Younger people	Discussed the impact that the pandemic has had on youth groups in the parish and the issue with low volunteer numbers.	In October 2022 the Youth Club started again by PC funding of the SYW assisted leader programme. PC to monitor and review user numbers and success.

2 – Clerk (S.Horton) told the PC that we were today notified that Galliers Homes has now applied for planning permission for 62 homes between the new estate and the Cricket Club. This needs to be responded in 31 days. No-one had seen the plans at the time, but we would review. Action – Request additional time to allow the PC to have a separate meeting to discuss this item. DH proposed extending to the 25th Feb 2023.

3 – MS noted that he had an interest as outgoing Chair of BHVH and remains a trustee. When discussing the VH he would be representing the VH, therefore no voting on behalf of the PC.

4 - The Committee discussed and formulated a list of potential schemes that we could focus on in the next 12 – 18months. Some ideas are already in progress, but we also discussed costs that the PC should consider when planning the budget.

5 - Precept - Committee agreed (5f - 1a) that we would keep the Precept at 0% generating £23,261 in 2023/24 to be received in April.

The consideration is that we haven't spent the budget in 2022/23 and spent circa £15k of a £22k budget. The PC wanted to pass any saving onto the Parish by way of a 0% increase.

1 member proposed a nominal 2% increase based on the inflation rate and that we would need to raise funds in the future in line with other PC's in Shropshire.

It was acknowledged that the Precept may need to be increased by at least 2% next year.
