We have reviewed minutes of the meeting on 11 May 2022 that demonstrate Sections 1 and 2 of the AGAR were approved at the same meeting and in the correct order. The smaller authority should ensure that all necessary information is provided on the AGAR in the future.
In the completion of the Annual Internal Audit Report, the internal auditor has drawn attention to significant weaknesses in relation to Internal Control Objective C regarding the contract of employment of the Clerk. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner
